Evaluation and proposal selection

Proposal evaluation has been carried out by independent reviewers of the Agencia Nacional de Evaluación y Prospectiva (ANEP) according to call criteria included in annex I. The budget will be distributed among projects until it is used up (a total of 150.000 Eur). The maximum funding per group will not exceed 25.000 €. The call will cover those proposals in which the funding can be guaranteed for all the participating areas, following ANEP's priority order.

ADITIONAL INFORMATION FOR GRANTED PROJECTS

Funds availability

Funds will be available on the CIBER intranet in the coming weeks. CIBER will notify when CECOs are available for use. Each IP group will have access to the budget requested in his project proposal.

Duration of the granted projects

The Project duration should not exceed 15 months after resolution communication. This time framework has been selected to ensure the possibility to have access to the H2020 2018-2020 calls. It is estimated that **projects' execution will start in November 2017**.

Reporting

The project team will need to send an economical and scientific report not later than 2 months from the end of project execution.

Annex I: Evaluation criteria ANEP

ANEP Evaluation will be over 100 points (representing a 90% of the final score of the project)

Scientific excellence (70 points over ANEP's evaluation)

- Novelty, originality and innovation potential of the proposal (20 points).
- Relevance, interest, translational dimension, applicability of the proposal (related impact at European level) (20 points).
- Adequacy in objectives' formulation (10 points).
- Conceptual approach (10 points).
- Methodological approach (10 points).

VIABILITY (30 points over ANEP's total score)

- Methodology, research design and work plan adequacy according to project aims (5 points).
- Adequacy of tasks' distribution (5 points).
- Capability to develop the proposed work plan considering risks management (10 points).
- International relevance of scientific-technical previous contributions in relation with this proposal (5 points).
- Adequacy of the proposed budget according to the described activities and project needs (5 points).

The remaining 10% of the final score will be assigned according to project alignment with specific priorities in the EC document for the 2018-2020 work program.
